Thank you for entering the American Lhasa Apso Club, Inc. Agility Trial!

Please check the final entry confirmation for your dog(s). If you find any errors, please notify the email at [agilityentry@agilitytrialservices.com](mailto:agilityentry@agilitytrialservices.com) (preferred) or by phone at (815) 469-5525. If you do not get a response from me, I did not get your email, so please follow up with a phone call. Pre-trial move-ups must be received not later than 6:00 pm CST on Monday, February 6, 2017. Day to day move-ups must be made by the close of Friday's trial for the Saturday trial and by the close of Saturday's trial for the Sunday trial. Close of the trial will be considered when the ribbons have been awarded for the last class of the day.

Dogs in the Master classes will run before those in the Excellent classes and Novice B will run before Novice A for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height (Small to Tall) except in the FAST classes where Preferred program dogs may run before dogs in the Regular program. At the club's discretion any of the level courses may be combined into one course with embedded sends (which will allow one course build and one walk through for all levels). **All FAST class walk throughs will be combined (8:10 am).** Entry numbers are preliminary, and subject to change contingent upon the move-up entries or withdrawals that may not have been received.

All dogs not having an AKC height card must be measured prior to competing. If a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. Be sure to arrive early enough before your judging time. Any exhibitor who runs without having their dog measured will lose any qualifying score earned. Unless you already check-marked on the entry form "My Dog Needs To Be Measured", please notify the Trial Secretary that your dog needs to be measured.

Food will **not** be available on site. There are several fast food restaurants within 15 minutes of the trial site.

Exhibitors and spectators are expected to keep the grounds clean. Handlers who do not clean up after their dogs will be dismissed from the trial with no monies refunded.

From north or southbound I-294: exit at I-80 west to I-57 south. Stay on I-57 south for 9.5 miles to the Manhattan-Monee Rd. exit and go west. Stay on Manhattan-Monee Rd. westbound for 6.5 miles and turn south (left) at Rt. 45 (stop sign with flashing light). Trial Site is 2.5 miles south on the west side of Rt. 45.

The easiest route for those taking the I-355 extension is I-355 south to I-80 east. Exit at Route 45. Stay on Rt.45 south (about 9 miles) to trial site.
