Please check the final entry confirmation for your dog(s). If you find any errors, please notify the trial secretary via email: [agilityentry@agilitytrialservices.com](mailto:agilityentry@agilitytrialservices.com) (preferred) or by phone at (815) 469-5525. If you do not get a response from me, I did not get your email, so please follow up with a phone call. **Pre-trial move-ups must be received not later than 6:00 pm CST on Monday, December 24, 2018.** Verbal requests will not be accepted. Day to day move-ups must be made by the close of Saturday's trial for the Sunday trial. Close of the trial will be considered when the ribbons have been awarded for the last class of the day. Move up forms will be available at the trial.

Dogs in the Master classes will run before those in the Excellent classes and Novice B will run before Novice A for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height. Entry numbers are preliminary, and subject to change contingent upon the move-up entries or withdrawals that may not have been received.

### **Set-Up**

Ring equipment unloading will be Friday at 2:00 pm. No exhibitors may put down mats, crates, chairs, etc. until 3:30 as the facility is partially in use. The facility will be available for set up to all exhibitors after 6:30 am on Saturday, December 29th. Crating is allowed in designated areas only. Crates should have a mat or blanket under them to protect the floor. Please economize your crating space. If it is necessary, you may be asked to reduce excess space with your neighbor. Additional crating space is available upstairs.

### **Facility**

The facility will be open at 6:30 am each day of the trial. Food will be available on the grounds for purchase.

### **MAX McCook has the following rules;**

- No outside food, beverages, alcohol or glass containers can be brought in the building
- Only water is allowed on the fields
- No dog grooming (including brushing) may be done in the building
- Do not exercise your dogs near the entrances to the Max or on the shrubbery.

Exhibitors and spectators are expected to keep the grounds clean. Handlers who do not clean up after their dogs or allow their dog to eliminate on the shrubbery will be dismissed from the trial with no monies refunded.

### **Ring Conflicts:**

You are expected to notify the Gate Stewards of conflicts. **Master/Excellent Standard 12", 8" & 4" (Ring 1) and T2B all heights (Ring 2) courses should be walked before their 8:00 am start times.**

**NOTE: Ring 1 will have precedence.**

From I-294: Exit I-294 at Ogden Avenue East. Continue East on Ogden Avenue for 2.6 miles to East Avenue. Go RIGHT (South) on East Avenue for 0.8 miles. Go LEFT (East) onto 47th Street. Go East on 47th Street for 0.8 miles to Vernon. Turn RIGHT (South) onto Vernon to MAX.

From I-55: Exit I-55 at IL-171 North. Continue North on IL-171 for 1.2 miles. Take the 47th Street Ramp exit and turn LEFT (West) onto 47th Street. Continue on 47th Street for .6 miles to Vernon. Turn LEFT (South) onto Vernon to MAX.

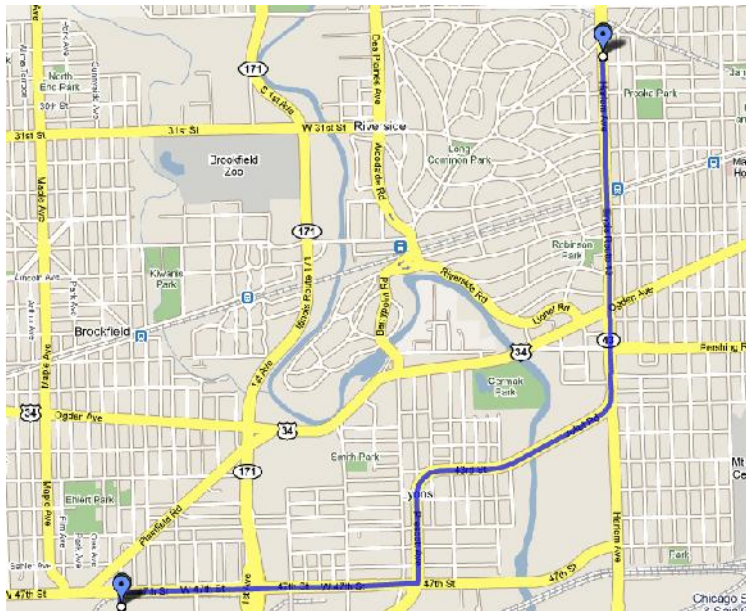
