Thank you for entering the Siberian Husky Club of America, Inc. 2018 National Specialty Agility Trial!

This trial is being held at CarDunAI Obedience Training Club, 10783 Wolf Drive, Huntley, IL 60142. The training center is in the southwest corner of the second building on the right. **There will be no barking dogs allowed in vehicles, they must be crated inside.** Fast food restaurants are nearby. Any additional questions regarding the site and its amenities should be directed to the trial chairperson.

IMPORTANT: TO ALL EXHIBITORS – PLEASE READ CAREFULLY. In order for CarDunAI to be able to keep renting this facility please adhere to these rules. Please note that the building will NOT OPEN TILL 7:00 AM. **DO NOT COME ANY EARLIER THAN 7:00 AM!** We know that some of your dogs are very exuberant and can't help but bark. For those that are not able to prevent your dogs from barking, YOU MUST park in between the buildings so our neighbors in homes to the west aren't disturbed.

Protective matting is required under all wire dogs crates and chairs to protect green flooring. Do not walk your dogs along the fence on the west side of the drainage area. Walk dogs on the east side of the drainage area and along the south side of the buildings. There will be NO Monday night set up.

NO PARKING IS PERMITTED in parking spots directly in front of the gymnastic club next to us.

Exhibitors and spectators are expected to keep the grounds clean. Handlers who do not clean up after their dogs will be dismissed from the trial with no monies refunded.

If we find anyone NOT following these rules they will be asked to leave without a refund of entry fees.

Please check the final entry confirmation for your dog(s). If you find any errors, please notify the trial secretary via email at agilityentry@agilitytrialservices.com (preferred) or by phone at (815) 469-5525. If you do not get a response from me, I did not get your email, so please follow up with a phone call. Pre-trial move-ups must be received not later than 6:00 pm CDT on Tuesday, October 9, 2018.

Dogs in the Master classes will run before those in the Excellent classes and Novice B will run before Novice A for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height. Entry numbers are preliminary, and subject to change contingent upon the move-up entries or withdrawals that may not have been received.

Our judge is a VMO. All dogs not having an AKC height card must be measured prior to competing. If a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. Be sure to arrive early enough before your judging time. Any exhibitor who runs without having their dog measured will lose any qualifying score earned. Unless you already check-marked on the entry form "My Dog Needs To Be Measured", please notify the Trial Secretary that your dog needs to be measured.

Site Directions:

From the east, take I-90 to the Route 47 exit. Go north on Route 47 approximately 3.7 miles to Oakcrest Drive and turn left (known as Algonquin Road to the right). Go less than .1 miles on Oakcrest to Wolf Drive and turn left.

From the west, take I-90 to the Route 20 exit. Go west (left) 1.6 miles to Harmony Road. Turn right on Harmony Road and drive 3.7 miles to the stop sign, then turn left to stay on Harmony Road. Drive to the next stop sign and turn right (Main Street). Drive 1.4 miles on Main Street to Route 47 and turn left. Go 0.4 miles north on Route 47 to Oakcrest Drive and turn left. (Algonquin Road to the right). Drive approximately 0.1 miles to Wolf Drive and turn left
